## **SCHOOL CORPORATION BOUNDARIES**

West Lafayette Community School Corporation (“WLCSC”) boundaries follow a general pattern as described below, but certain exceptions do exist and are listed following the general description. Apartments are also listed since some are actually split between WLCSC and the Tippecanoe School Corporation (“TSC”).

The northern boundary line for WLCSC is County Road 350 North from Soldiers Home Road on the East to just West of the Whirlpool Corporation on the West. Only homes on the South side of County Road 350 North are included in the WLCSC district.

The western boundary extends South from a point on County Road 350 North located at the western boundary of the Whirlpool Corporation property directly southward to U.S. Highway 52 and then follows Highway 52 South to Lindberg Road and West on Lindberg Road to the eastern boundary of the Purdue North Golf Course then South to Cherry Lane and back East on Cherry Lane to Northwestern then South to Stadium Avenue and West on Stadium Avenue to Russell Street. Homes on both sides of Russell Street are included in the WLCSC district. Homes on Russell Street, Waldron and University between State Street on the south and Stadium Avenue on the North are in the WLCSC district, but this is an enclave separate from the remainder of the district. Northwestern continues as the western boundary from Stadium Avenue to Grant Street, the property on the East side of Grant Street is within the WLCSC district, South to State Street where the boundary follows State Street West to Marsteller and on South to the railroad tracks.

The South boundary then follows the railroad tracks to the river.

The East boundary extends North from the Railroad tracks to Harrison Bridge (Highway 231 and 43). The East boundary then extends on North to include both sides of North River Road (Highway 231 and 43) to Catherwood Street. Both sides of Catherwood Street are included with the boundary that extends on North to include both sides of Happy Hollow Road (Highway 443) to Foster Drive. Both sides of Foster Drive are within the TSC district as are the Parkway Apartments 3. Other apartments along this general East boundary are split with some of the apartment buildings in the WLCSC district and others in the TSC district. The boundary extends North of Sagamore Parkway following Soldiers Home Road, but including all of Glenwood Heights (Sharon Road, Juniper Court, Dogwood Court, Myrtle Drive, Willow Drive, Sharon Court, and Magnolia Court). Extending North from Glenwood Heights, the East boundary includes only the West side of Soldiers Home Road to the intersection with County Road 350 North.

The following apartments are split with some units in the WLCSC district and some in the TSC district:

Nobb Hill (Happy Hollow Road)

- Buildings 5, 6 and 7 are in the WLCSC district.
- All others are in the TSC district.

Waterfront (WL Levee area – Brown St.)

- Buildings 100, 200, 400 and 500 are totally within the WLCSC district, plus apartments 301, 302, 305, and 306 in Building 300.
- All others are in the TSC district

Williamsburg on the Wabash (North River Road)

- Buildings 100, 600, 1200, 1300, 1400, and 1500 are in the WLCSC district
- All others are in the TSC district

Tower of Ivory (Happy Hollow Road - built 2004)

- Buildings 128, 132, 136, 140, 144, 148, 152, 156, are in the WLCSC district
- All other buildings are in TSC.

Chardonnay Subdivision (North River Road)

- House numbered 1612 N. River Road, WLCSC district; 1604, 1620 TSC

Villefranche Drive (in the Tower of Ivory neighborhood)

- Houses numbered 128, 132, 136, 140, 144, 148, 152, 156 are in WLCSC district

**NOTE:** School and civil city boundaries are NOT contiguous and questions regarding the appropriate school district for specific properties should be directed to the Administrative Offices of the West Lafayette Community School Corporation, 1130 N.
